WipeErase® has a writing surface that is built to last and includes a 10-year warranty guaranteeing its erasability properties. Be sure to follow the care and maintenance instructions to ensure your writing surface looks fresh and new for years to come.

TEN YEAR LIMITED SURFACE WARRANTY

1. Drytac Corporation ("Drytac") will provide a Surface warranty to the original purchaser (the "Purchaser") that Drytac WipeErase dry erase products (the "Products") sold to Purchaser will be free from manufacturing defects and, under normal use and service, will not chip, crack or lose its original wipe ability properties for a period of ten (10) years from date of original manufacture. This limited warranty does not include the adhesive coating or its adhesive to any substrate on the WipeErase products and is only the performance of the writing surface or face film only.

2. The above warranty applies solely to Products that have been properly installed, and maintained in accordance with Installation Instructions as well as the Care and Maintenance Procedures provided by Drytac at the time of purchase. The purchaser's sole remedy in the event of failure of the product in accordance to the above warranty shall be only for replacement of the defective Product. Drytac shall not be responsible for any consequential losses other than replacement of any defective Product, including removal, shipping or reinstallation costs, or other incidental expenses. Drytac reserves the right to make such inspections as may be necessary to determine the cause of defect and eligibility for warranty coverage.

3. To initiate a claim for warranty, the Purchaser should contact their Drytac office, listed below, with Attn: Customer Service. Full details of the defect or failure, including any photographs to depict the condition or samples relating failure, should be included for prompt resolution of any claim.

4. Drytac makes no other warranty, express or implied, with respect to the products and Drytac specifically disclaims any implied warranty of merchantability and fitness for a particular purpose. No other representation or warranty, including but not limited to statements of quality, suitability for use or performance, whether made by employees of Drytac, distributors or any sales agent, shall be considered a warranty by Drytac for any purpose or create any liability of Drytac.
